FRONT BRAKES \ ROTORS REQUIRED REPLACEMENT AFTER ONLY 20,000 MILES. I HAVE NOTICED OTHER RECALLS ON RAM 1500 FRONT DISC BRAKES (ROTOR PROBLEMS: FATIGUE BUT NOT ON MY PARTICULAR VIN). I ALSO NEED TO TAKE THE VEHICLE IN YET AGAIN FOR THE SAME PROBLEM ONLY 5 DAYS AFTER INITIAL "REPAIR"! I LOVE MY DODGE RAM, BUT I FEEL THERE IS SOMETHING DEFINITELY WRONG WHEN MYSELF AND OTHERS HAVE TO REPLACE BRAKES SO EARLY ON A RELATIVELY NEW VEHICLE. PERHAPS CHRYSLERS RECALL # 788 SHOULD BE REOPENED FOR FURTHER INVESTIGATION?*AK
