THE MOST PARTICULAR ONE IS THE LEAKING ENGINE OIL LINES, WHICH IS A WIDE SPREAD ISSUE WITH THE GM S-10 FAMILY (3 WEEK BACK LOG JUST TO GET THE PARTS). I'M ALSO A MEMBER OF A MAILING LIST ASSOCIATED WITH THE S-10 SERIES TRUCKS BY GM AND IT CONTAINS WELL OVER 200 MEMBERS MOST OF WHICH HAVE EXPERIENCED IDENTICAL PROBLEMS WITH THIS PARTICULAR MAKE/ MODEL. I'M NOT IN ANY WAY, SHAPE OR FORM DISSATISFIED WITH THE DEALER HERE IN VIRGINIA THAT HAS PERFORMED ANY OF MY REPAIRS AND I'M ALSO NOT DISSATISFIED WITH THE DEALER I PURCHASED THE TRUCK FROM WHEN NEW.
