BECAUSE OF THIS THE DOOR WILL NOT ALWAYS LATCH FULLY AND THE DOOR CAN SWING OPEN WHILE THE VEHICLE IS IN MOTION. I HAD IT REPAIRED ONCE BY A PROFESSIONAL BODY REPAIR MAN, AND IT HAS NOW FAILED A SECOND TIME.
