TIRE BLOWOUT; DRIVING WITH CRUISE CONTROL @ APPROX. 60 MPH ON OPEN HIGHWAY. LEFT/REAR TIRE (DRIVER'S SIDE) SUDDENLY BLEW OUT WITHOUT WARNING OR PRIOR EVIDENCE OF POSSIBLE TIRE FAILURE. TREAD IS VERY MUCH SEPARATED AND SIDEWALLS, BOTH INSIDE AND OUTSIDE (AS RELATING TO TIRE PLACEMENT ON TRUCK) HAVE APPROX. 30-40 SLASHES IN THEM. IT APPEARS AS THOUGH THE TIRES SECTIONS (POSSIBLY BELTS?) JUST CAME APART AND THE TREAD PORTION OF THE TIRE CAME OFF. TIRE BLOWOUT; DRIVING WITH CRUISE CONTROL @ APPROX. 60 MPH ON OPEN HIGHWAY. LEFT/REAR TIRE (DRIVER'S SIDE) SUDDENLY BLEW OUT WITHOUT WARNING OR PRIOR EVIDENCE OF POSSIBLE TIRE FAILURE. TREAD IS VERY MUCH SEPARATED AND SIDEWALLS, BOTH INSIDE AND OUTSIDE (AS RELATING TO TIRE PLACEMENT ON TRUCK) HAVE APPROX. 30-40 SLASHES IN THEM. IT APPEARS AS THOUGH THE TIRES SECTIONS (POSSIBLY BELTS?) JUST CAME APART AND THE TREAD PORTION OF THE TIRE CAME OFF.
