DOOR LOCKS WILL LOCK AND UNLOCK ON THEIR OWN. AT TIMES SLIDER WON'T OPEN PREVENTING OCCUPANTS FROM EXITING VEHICLE. FRONT DOORS HAVE LOCKED AND COULDN'T BE UNLOCKED TRAPPING OCCUPANTS IN CAR. LOCKS ON DOOR SHOW VEHICLE LOCKED, ALARM CAN BE SET BUT FRONT DOORS CAN BE OPENED. NO WAY TO KNOW IF VAN IS REALLY LOCKED OR NOT. VAN WILL SOMETIMES LOCK ON THEIR OWN SOMETIMES LOCKING US OUT. VAN HAS BEEN REPAIRED 8 TIMES BUT PROBLEM STILL CONT. DOOR ACTUATORS HAVE BEEN REPLACED 5 TIMES BUT STILL MALFUNCTION AT TIMES. AT TIMES ALARM WILL GO OFF BY ITSELF AND CAR CAN BE STARTED AND DRIVEN WITH ALARM SOUNDING.*AK
