MY BIKE IS EQUIPED WITH THE TC88 MOTOR AND I HAVE BEEN NOTIFED THAT THE REAR CAM BEARING COULD FAIL. THE BEARING DISIGN WAS CHANGED DURING THE 2000 MODEL YEAR. WHAT IF IT FAILS AT HIGHWAY SPEED AND THE MOTOR LOCKS UP? THIS WOULD NOT BE GOOD ON A MOTORCYCLE. I FEEL THE COMPANY SHOULD RECALL MY BIKE AND REPAIR THE PROBLEM BEFORE SOMETHING BAD HAPPENS. I HAVE CONTACTED HARLEY DAVIDSON MOTOR COMPANY AND WAS TOLD THEY WILL EXTEND MY BIKE WARRANTY ON THE CAM BEARING TO 5-YEAR/50,000 MILES. I FEEL THE CAM BEARINGS SHOULD LAST LONGER THEN 50,000 MILES. THE CUSTOMER SERVICE DEPARTMENT OF ANDREWS CAMS IS SAYING THAT IF YOU HAVE ONE OF THE BIKES WITH THE BAD CAM BEARING, IT'S GONNA BLOW UP, IT'S JUST A QUESTION OF WHEN.*AK
