DUNLOP WILL NOT DO ANYTHING ABOUT THIS PROBLEM EXCEPT CREDIT ME THE DIFFERENCE ON TIRE THE TREAD WEAR. THE SAFETY, COST AND INCONVENIENCE IS MY PROBLEM. I HAVE HAD TWO TIRES ON THE FRONT OF MY CAR WITHIN 3,500 MILES OF EACH OTHER DEVELOP THE SAME IDENTICAL PROBLEM, A BLISTER ON THE SIDEWALL OF THE TIRE. DUNLOP WILL NOT DO ANYTHING ABOUT THIS PROBLEM EXCEPT CREDIT ME THE DIFFERENCE ON TIRE THE TREAD WEAR. THE SAFETY, COST AND INCONVENIENCE IS MY PROBLEM.
