OCCURS DAILY WITH VARYING INTENSITY, ON ANY ROAD SURFACE/CONDITION, HOT OR COLD, IN EITHER DIRECTION DURING SAME DRIVING PERIOD AND SOMETIMES NOT AT ALL FOR A SHORT PERIOD. ALIGNED TWICE, THRUST BEARINGS, BUSHINGS, PLATES REPLACED, TEST-DRIVEN. WHILE PROBLEM OCCURS DAILY, IT DOES NOT OCCUR EVERY MOMENT WHICH MAY BE WHY IT DOESN'T SHOW UP WHEN ROAD-TESTED. THIRD SERVICE APPOINTMENT HAS BEEN BOOKED. CONCERNED BECAUSE WITHIN A FEW SECONDS VEHICLE CAN BE IN ANOTHER LANE (NOT THAT I DRIVE WITHOUT MY HANDS ON THE WHEEL). THANKS!
