## NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

VAN WAS IN FOR NORMAL SERVICE AND MECHANIC ATTEMPTED TO DRIVE VAN INTO SERVICE BAY WHEN HE HEARD A SNAP. THE VAN STOPPED MOVING. WHEN IT WAS CHECKED THEY FOUND THE AXLE SNAPPED AND AT THE PLACE OF FAILURE CORROSION AND RUST WAS FOUND UNDER RUBBER COVERING. OUR CONCERN WAS THAT THE FAILURE COULD HAVE OCCURRED WHILE TRAVELING ON A HIGHWAY RESULTING IN SERIOUS INJURY OR DEATH.
