CAR IS A VERY LOW MILAGE VEHICLE, FORMERLY OWNED BY AN ELDERLY MAN. CAR HAD 10,200 MILES ON IT IN SEPT. 2000 WHEN PURCHASED DIRECTLY FROM ESTATE. PROBLEM FIRST APPEARED ON 3/9/01 AFTER I'VE DRIVEN THE CAR ABOUT 9000 MILES. \*AK
