ACCORDING TO WITNESSES, MY CAR WAS ALL OVER BOTH HIGHWAYS, ALMOST BEEN KILLED BY TWO 18 WHEELERS AND ALTIMATELY CRASHING ON A GUARD ON THE SOUTH DIRECTION. I LOST CONSCIENCE AND WHEN I CAME TO I SAW ALOT OF PEOPLE OVER ME AND THEN TAKEN TO THE FIRST EMERGENCY. ON 3/11/00 AT ABOUT 6:35PM, I WAS COMING FROM DALLAS TO HOUSTON. JUST BEFORE WYLLIS MY CAR WENT TOTALLY OUT OF CONTROL AFTER MY RIGHT FRONT TIRE WENT TO PIECES. ACCORDING TO WITNESSES, MY CAR WAS ALL OVER BOTH HIGHWAYS, ALMOST BEEN KILLED BY TWO 18 WHEELERS AND ALTIMATELY CRASHING ON A GUARD ON THE SOUTH DIRECTION. I LOST CONSCIENCE AND WHEN I CAME TO I SAW ALOT OF PEOPLE OVER ME AND THEN TAKEN TO THE FIRST EMERGENCY.
