THE ELECTRICAL WORK ON THE CAR IS IN TERRIBLE CONDITION. I PURCHASED THE CAR WITHOUT NOTICING A FAILURE IN THE REVERSE LIGHTING. THE REVERSE LIGHTS FAILED TO WORK THEREFORE SINCE PURCHASING THE CAR IN GREENVILLE MY DAUGHTER COMMUTED FROM GREENSBORO TO GREENVILLE 3 TIMES TO HAVE THE PROBLEM CORRECTED. NEXT THE SYSTEM FAILED AGAIN AND WITH THE SAME REVERSE LIGHTING PROBLEM. I RETURNED TO CAR TO THE DEALER AND THE SYSTEM WAS CORRECTED, HOWEVER THE PANEL LIGHTS FAILED AND I HAVE HAD THE SAME PROBLEM UP UNTIL THIS POINT.
