THE BRAKES HAVE BEEN A PROBLEM SINCE ABOUT 9,000 MILES. THE CAR HAS HAD BRAKE SERVICE 3 TIMES AND WILL NOW GO IN FOR A FOURTH TIME. THE FRONT END SHIMMIES WHEN STOPPING, AND THE BRAKES PULSE, MAKING VERY UNSAFE CONDITIONS AT HIGHWAY SPEEDS. CHRYSLER DISAVOWS A PROBLEM, HOWEVER, THERE ARE NUMEROUS COMPLAINTS ON YOUR CONSUMER DATABASE, AND THERE IS A SERVICE BULLETIN(050398) LISTED. ADDITIONALLY, THERE IS A RECALL FOR BRAKE PROBLEMS WITH THE 1996-1999 MODELS. I BELIEVE YOU ARE MISSING A SERIOUS SAFETY ISSUE.
