REAR BRAKE PADS ON MY CAR ARE COMPLETELY WORN DOWN TO METAL AND THE METAL IS CUTTING INTO THE ROTORS, THIS IS ON BOTH REAR WHEELS ASSEMBLIES. I TOOK THE CAR TO THE DEALER TO HAVE THEM REPLACED UNDER WARRANTY AND WAS TOLD THIS COULD NOT BE DONE SINCE I HAD OVER 12,000 MILES ON THE CAR, EVEN THOUGH THE CAR IS ONLY 10 MONTHS OLD. MY CAR IS NOT SAFE TO DRIVE WITHOUT REAR BRAKES, THOUGH THE DEALER LET ME DRIVE AWAY ANYWAY. MY PROBLEM IS THIS, THE VOLVO DEALER, TWO DIFFERENT SERVICE MANAGERS, AND VOLVO NORTH AMERICA CUSTOMER SERVICE HAVE INFORMED ME THAT THIS SITUATION IS "NORMAL" AND THEY EXPERIENCE THIS TYPE OF PROBLEM WITH MANY CUSTOMERS ON A WEEKLY BASIS. IF THIS IS INDEED TRUE, THEN WHY WOULD VOLVO NOT MAKE A NOTATION IN THE OWNERS MANUAL, UNDER THE MAINTEN
