THE DESIGN OF THE SEAT MOUNTING IS UNSAFE. THE SEAT IS MOUNTED TO A WEAK CROSS BRACE INSTEAD OF THE MAIN SEAT FRAME RAILS. THIS DESIGN IS DOOMED TO REPEATED FAILURES AND IS UNSAFE. IF THE SEAT WAS MOUNTED BY THE MAIN FRAME RAILS THERE WOULD BE NO PROBLEMS. CHEVROLET SHOULD REDESIGN THE SLIDE BRACKET TO MOUNT TO THE PROPER MOUNTING POINTS.\*AK
