NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

ON MARCH 10, 2001 I NOTICED THAT MY LEFT HEADLIGHT LENS COVER AND BULB WERE MISSING. THE NEXT DAY I CALLED THE DEALER FOR A REPLACEMENT AND WAS TOLD THERE WAS A BACKORDER & I WOULD BE CONTACTED WHEN AVAILABLE. THREE DAYS LATER I WAS DRIVING HOME FROM SCHOOL AT 9:00 PM WHEN I REALIZED ON A DARK STRETCH OF ROAD THAT I HAD NO HEADLIGHTS. I TURNED ON MY HIGH BEAMS WHICH ILLUMINATED, ON THE RIGHT SIDE, FOR ABOUT 2 SECONDS AND THEN THE BULB BLEW OUT. THE OTHER HEADLIGHT LENS HAD FALLEN OFF THE CAR AND THE BULB BROKE OFF WHILE DRIVING. I HAD THE POLICE CHECK MY CAR BECAUSE THE DEALERSHIP INFERRED THAT SOMEONE MUST HAVE TRIED TO STEAL MY HEADLIGHTS. THE POLICE CONCURRED THAT THERE WAS NO DAMAGE AROUND THE HEADLIGHT AREA AND IT WAS MORE THAN LIKELY THAT THE LOSS OF THE HEADLIGHT WAS
