NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE PROBLEM IS A POTENTIALLY CATASTROPHIC ONE AS A SINGLE FAILURE OF ANY COMPONENT FROM THE REAR OF THE TRANSMISSION TO THE REAR WHEELS WILL, WHEN PARKED, WILL ALLOW THE VEHICLE TO MOVE. THE ONLY PARKING BRAKE PROVIDED IS A DRUM BRAKE AT THE TRANSMISSION OUTPUT SHAFT. WHEN PARKED BESIDE THE ROAD IN STEEP TERRAIN LIKE ROCKY MTN NAT'L PARK WITH NO GUARD RAIL A SINGLE FAILURE WILL LIKELY RESULT IN LOSS OF LIFE AS WELL AS VEHICLE. THE BOLTS ON MY FRONT U-JOINT HAVE ALREADY BEEN FOUND LOOSE. THIS IS UNACCEPTABLE. ALL AUROMOBILES AND OLDER MOTORHOMES HAVE BOTH CABLE OPERATED REAR PARKING BRAKES AS WELL AS A TRANSMISSION LOCK. ANY SINGLE FAILURE IN EITHER SYSTEM WILL STILL LEAVE THE VEHICLE SECURELY PARKED. I AM NOT WILLING TO BET MY LIFE OR MY WIFE'S LIFE ON NOT HAVING A S
