BRAKES FAILED TO WORK WHEN WET. THERE WAS ABOUT A 3-4 DELAY BEFORE THE BRAKES WOULD START TO WORK. THIS ONLY HAPPENS DURING VERY HEAVY RAIN OR AFTER DRIVING THROUGH A PUDDLE. THIS IS NOT THE SAME AS PREVIOUS CARS I HAVE HAD WHERE THE BRAKING FORCE WOULD BE LESS WHEN WET. THE BRAKES ON THIS CAR PROVIDE LESS THEN 20% OF BRAKING FOR 3-4 SECONDS AND PRESENTS A VERY DANGEROUS SITUATION. *AK
