IN THE EVENT OF A REAR END COLLISION THE REAR SEAT OCCUPANT'S HEAD COULD BREAK THE REAR WINDOW AND STRIKE THE METAL SILL RESULTING IN SEVERE HEAD INJURY. FORD HAS ADDRESSED THIS PROBLEM IN THE F150 SUPERCREWS BUILT AFTER 10/2000 BUT HASN'T DONE ANYTHING FOR THOSE WHO PURCHASED VEHICLES BUILT PRIOR TO THE PRODUCTION CHANGE. *AK
