I HAVE COMPLAINED ABOUT THE TRANSMISSION BANGING WHEN GOING FROM 1ST TO 2ND GEAR. I WAS TOLD THAT THIS WAS NORMAL EVERYTIME I BROUGHT IT IN FOR A CHECK UP. THIS HAS BEEN GOING ON SINCE THE TIME I BOUGHT IT. THE TRANSMISSION FINALLY FAILED AT THE DATE MENTIONED. I LOST REVERSE BUT I HAD DRIVE. AS I DROVE IT HOME THE RPM'S WERE HIGH AND IT BARELY SHIFTED. I BARELY GOT IT HOME SINCE THE TRANSMISSION WAS SLIPPING BETWEEN GEARS ALL THE WAY HOME. I LIMPED IT HOME THEN HAD IT TOWED IN THE NEXT MORNING. I GOT THE VAN BACK 6 DAYS LATER. NOW IT SLIPS BEFORE GOING TO INTO 1ST GEAR. IT NEVER DID THAT BEFORE WITH THE 1ST TRANSMISSION. IT ALSO SLIPS BETWEEN FIRST AND SECOND AGAIN. I WAS TOLD THAT WAS NORMAL. I HAVE DRIVEN 4 OTHER ASTRO VANS THE SAME YEAR AND MAKE AND THEY DO NOT SLIP BETWEEN GEAR
