ALL 4 ORIGINAL TIRES HAVE SEPARATED AND BEEN REPLACED (15K MILES AND 24K MILES). ELECTRICAL STILL CAUSING POWERTRAIN AND ACCESSORY-RELATED (RADIO) RECURRINGLY FAIL. ALL 4 ORIGINAL TIRES HAVE SEPARATED AND BEEN REPLACED (15K MILES AND 24K MILES). ELECTRICAL STILL CAUSING POWERTRAIN AND ACCESSORY-RELATED (RADIO) RECURRINGLY FAIL.
