DSC/EML - ACCORDING TO MANUAL, ITS AN SYSTEM MALFUNCTION AND A PROBLEM WITH THE TRACTION CONTROL; LIGHT STAYS ON WHEN DRIVING. FUEL INJECTION - LIGHTS STAYS ON WHEN DRIVING. EXTERIOR MIRROR - WOULD NOT TILT WHEN IN REVERSE. BRAKES LIGHT - INSTRUMENT LIGHT STAYS ON WHEN DRIVING. (OTHER)SERVICE ENGINE - INSTRUMENT LIGHT STAYS ON WHEN DRIVING AND BEEPS.
