HOWEVER, WHEN THE PREVIOUS OWNER LEARNED OF OUR WRECK, HE PROVIDED ME WITH RECEIPTS WHICH SHOWED THAT TWO OTHER TIRES FROM THE ORIGINAL FOUR FAILED AT 153,240 MILES AND 143,911 MILES. HE ORIGINALLY BOUGHT THEM AT 106562 MILES. THESE TIRES ARE TOUTED AS GOOD FOR 70,000 MILES AND THEY ARE GOING TO GET SOMEONE KILLED. MARVIN MORRIS AT 281-579-2174 WITNESSED THE TIRE SHREDDING AS DID KAWAL PATEL AT 281-575-4360 (ALSO 281-693-2353).\*AK

HOWEVER, WHEN THE PREVIOUS OWNER LEARNED OF OUR WRECK, HE PROVIDED ME WITH RECEIPTS WHICH SHOWED THAT TWO OTHER TIRES FROM THE ORIGINAL FOUR FAILED AT 153,240 MILES AND 143,911 MILES. HE ORIGINALLY BOUGHT THEM AT 106562 MILES. THESE TIRES ARE TOUTED AS GOOD FOR 70,000 MILES AND THEY ARE GOING TO GET SOMEONE KILLED.
