THESE CUPHOLDERS WERE REPLACED ON THE 2000 MODEL YEAR, BUT THOSE OF US WITH THE 1999 ENDED UP WITH UNSAFE EQUIPMENT. I THINK FORD NEEDS TO RECALL THE POORLY ENGINEERED PART TO PREVENT FUTURE INJURIES.*AK
