MASTER SWITCH WAS REPLACED AND SOFTWARE DOWNLOADED. IT TOOK ALMOST ONE MONTH TO FIX MY CAR.PROBLEM NUMBER 2ON 02/13/2001 DURING HIGH SIDE IMPACT WITH ANOTHER CAR NONE OF AIRBAGS AND NONE OF SIDE IMPACT PROTECTION SYSTEM WORKED.
