OCCURS EVERY TIME BRAKES ARE APPLIED, AND I FEAR A COLLISION EVERY TIME I USE THE BRAKES. SERVICING HAS NOT HELPED, PROBLEM LIES WITHIN THE DESIGN OF THE BRAKE SYSTEM. \*AK**
