I FEEL WITH THE LOW MILAGE OF 53,000 THIS SHOULD NOT BE A PROBLEM AND COULD HAVE RESULTED IN MORE SEVERE PROBLEMS IF PUMP HAD COMPLETELY LEAKED EMPTY CAUSING LOSS OF POWER STEERING. \*AK
