I BLEW AN ENGINE AT 55MPH, DISCOVERED THAT OIL WEREN'T REACHING THE ENGINE EVENTHOUGHT THE OILSTICK SHOWED FULL. I BOUGHT A NEW ENGINE FROM BAYERISCHE MOTOREN WERKE, INSTALLED TOTAL SPENT \$10,000.00, THE REPAIR OF THE SEAT AND HEATING SYSTEM IS STILL PENDING AND I AM REQUESTING SOME KIND OF RE-IMBURSEMENT FOR THE ENGINE REPAIR, NEED A NEW SEAT AND REPAIR OF THE HEATING SYSTEM. THE DRIVERS SEAT \$1,500.00 AND THE HEATING SYSTEM 3,000.00 FOR A TOTAL OF \$14,500.00. AS FOR THE DRIVERS SEAT I'M VERY FORTUNATE TO EXCAPE SERIOU INJURY, BECAUSE WHEN THE SEAT BROKE MY FEET WENT STRAIGHT UP
