I HAVE HAD TO REPLACE THE BRAKE ROTORS TWICE ON THIS VEHICLE SINCE PURCHASED NEW. DEALER CUT ROTORS UPON INITIAL COMPLAINT AND PROBLEM RETURNED WITHIN 3000 MILES. DEALER OFFERED TO REPLACE ROTORS AT MY COST INFORMING ME THEY WERE NOT COVERED UNDER WARRANTY. ROTORS WERE AGAIN REPLACED AT 60,000 MILES AND PROBLEM HAS AGAIN RETURNED ONLY 2,000 MILES LATER. THIS APPEARS TO ME TO BE A DESIGN FAILURE AS I HAVE SPOKEN TO MANY PEOPLE WHO HAVE EXPERIENCED THIS VERY SAME PROBLEM.\*AK
