THE INTEGRATED CHILD RESTRAINTS HAVE A CHEST LATCH. THIS LATCH IS ABLE TO BE PULLED APART BY MY 18 MO. OLD DAUGHTER WITHOUT UNLATCHING. I INVESTIGATED, AND FOUND THAT THEY ALL COME APART EASILY. BOTH CHILD SEATS WERE REPLACED AND THE NEW ONES ARE ABLE TO BE UNLATCHED BY SIMPLY PULLING THE BUCKLE APART. ONCE, MY DAUGHTER WAS ABLE TO GET OUT OF THE CAR SEAT COMPLETELY AS WE WERE DRIVING DOWN THE ROAD. AND I AM CONCERNED IN A CRASH THAT THE LATCH WON'T HOLD, OR A CHILD CAN UNLATCH IT JUST BY PULLING ON IT.
