AFTER SERVICE OF VEHICLE, I LEFT THE DEALER. WHEN I LEFT THE PARKING LOT I HEARD A BANG FROM UNDER THE VEHICLE. I TOOK THE VEHICLE BACK TO THE DEALER AND WENT FOR A ROAD TEST WITH ONE OF THE SERVICE EMPLOYEES. HE CONCURED THAT THERE WAS A NOISE BUT COULD NOT TELL ME EXACTLY WHAT WAS WRONG WITH THE TRUCK. SERVICE WAS BOOKED THE FOLLOWING DAY SO I ARRANGED TO DROP THE TRUCK OFF TWO DAYS LATER. I WAS THEN TOLD THAT THE LOWER BALL JOINTS WERE BAD ON BOTH SIDES. I WAS QUOTED A PRICE APPROX \$200.00 OVER THE AREA'S SERVICE CENTERS. THE SERVICE CENTER TOLD ME THAT THE VEHICLE SHOULD NOT BE DRIVEN BECAUSE IT "WAS NOT SAFE". AFTER RESEARCHING THE SUSPENSION I FOUND THAT THERE ARE MANY OTHERS WHO HAVE HAD SIMILAR PROBLEMS. I FEEL THAT SINCE THE DEALERSHIP HAS A RE-OCCURING PROBLEM
