THE C/S OIL LIGHT FLASHED ON AND OFF. THE CAR WAS IMMEDIATELY TAKEN TO THE DEALER. THEY DIAGNOSED A LEAKING FRONT CAMSHAFT SEAL. THE DEALER'S REPAIR INVOICE LISTED THE PROBLEM AS "FRONT CAM SEAL FELL OUT". THERE WAS OIL ALL OVER THE ENGINE AND THE DRIVEWAY. CAMSHAFT SEALS DON'T 'FALL OUT' OF PROPERLY DESIGNED ENGINES. THERE IS OBVIOUSLY AN ENGINE DESIGN DEFECT HERE.
