BRAKE ROTORS REPEATEDLY WARP CAUSING SEVERE SHAKING IN STEERING DURING HIGHWAY SPEED BRAKING AND MODERATE SHAKING AT SLOWER SPEEDS BRAKING. THIS IS A PERSISTANT PROBLEM WITH THIS MODEL JEEP - MINE, AS WELL AS OTHERS ACCORDING TO REPORTS I'VE READ. JEEP REPAIRS THIS DEFECT UNDER WARRANTY BY USING AN "ON-THE-CAR LATHE". THIS IS A TEMPORARY FIX AT BEST AS THESE BRAKE ROTORS ARE OF DEFECTIVE MANUFACTURING. . CHRYSLER/JEEP IS STALLING A RECALL BY ATTEMPTING THESE INEFFECTIVE REPAIRS IN MY OPINION. I BELIEVE A SAFETY RECALL IS URGENT. *AK
