ON FIVE SEPARATE OCCASIONS AUTO COMPLETELY LOST ALL POWER. THREE OF THESE INCIDENTS OCCURRED ON MAIN ROAD STREETS, TWO OCCURRED AT ABOUT 65 MPH ON THE FREEWAY. I HAD IT TOWED IN EACH OCCASION, TO DIFFERENT REPAIR SHOPS SINCE I BROKE DOWN IN 5 DIFFERENT LOCATIONS. AFTER DESCRIBING THIS INCIDENT TO A REPAIR SHOP, THE OWNER SAID THAT HONDA HAS A RECALL OUT ON IGNITION WIRE WHICH IS THE CONTINUOUS CAUSE OF THIS PROBLEM. HOW DO I GO ABOUT HAVING HONDA FIX THIS PROBLEM FOR THE RECALL. IT HAS ALREADY COST ME 5 TOWS, 5 MIS-REPAIRS, AND ALMOST A FREEWAY CRASH. THANK YOU FOR YOUR TIME.
