THE LEFT REAR TIRE FAILED CATASTROPHICALLY. TREAD VIOLENTLY SEPARATED FROM THE TIRE DOING CONSIDERABLE DAMAGE TO THE VEHICLE. LOSS OF CONTROL OF VEHICLE OCCURRED, BUT NO CRASH RESULTED. THE FAILED TIRE REMAINED FULLY INFLATED AFTER THE VEHICLE WAS BROUGHT TO REST. THE FAILED TIRE SLOWLY LOST PRESSURE AFTER THE INCIDENT AND WAS AT A LOW PRESSURE WHEN IT WAS BROUGHT TO A GOODYEAR DEALER 40 HOURS AFTER THE FAILURE OCCURED.
