NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

I HAD MY 1996 CROWN VICTORIA IN FOR ITS' REGULAR PREVENTATIVE MAINTENANCE. MY MECHANIC (WHOM I HAVE BEEN GOING TO FOR 15 YEARS) DISCOVERED THE COOLANT WAS LOW. UPON FURTHER INSPECTION; THE MANIFOLD WAS FOUND TO HAVE A CRACK IN IT AND WAS SLOWLY LEAKING OUT COOLANT. THIS IS THE ORIGINAL FORD PART AND IS NOT UNDER A RECALL AT THIS TIME. HOWEVER, UPON CONTACTING MY FORD DEALER - I WAS INFORMED THAT THIS PART HAS BEEN RECALLED FOR THE POLICE VEHICLES (SAME MAKE, MODEL AND YEAR). I HAVE BEEN IN CONTACT WITH FORD. THEY SAID IF THERE WOULD BE A RECALL, I WOULD BE ELIGIBLE FOR A REFUND FOR THIS REPAIR. FORD GAVE ME THE NHTSA'S WEB SITE SO I CAN MOVE FORWARD ON A RECALL FOR THIS FORD PART. THIS IS CLEARLY A DEFECTIVE PART - GIVEN THE LOW MILEAGE (LESS THAN 65,000) OF MY CAR. I WANT TO KNOW WHAT I
