THE BRAKES LOCK UP AT THE SLIGHTEST PRESSURE. SEEMS TO BE WORSE WHEN FIRST STARTING OUT WITH VEHICLE COLD OR WHEN THE ROADS ARE WET, BUT OCCURS AT ANYTIME WHILE TRYING TO BRAKE. WHEN THE BRAKE IS APPLIED IT PULLS TO THE RIGHT AND ALSO THE BRAKES LOCK UP, THE TIRES SKID, AND YOU HEAR A HUMMING NOISE COMING FROM SOMETHING. (OBVIOUSLY IN THE BRAKING COMPONENT SOMEWHERE) I HAVE TAKEN IT TO A GMC DEALERSHIP 3 TIMES BUT THEY HAVE FAILED TO SOLVE THE PROBLEM. THEY SAY THEY CAN'T DUPLICATE THE PROBLEM AND CAN'T FIND ANY PROBLEM WITH THE BRAKES. I ASKED THEM SPECIFICALLY TO DRIVE THE VEHICLE, ESPECIALLY ONE DAY WHILE IT WAS IN THEIR CARE AND IT WAS RAINING SINCE IT LOCKS UP MORE WHEN WET. BUT I QUESTION WHETHER THEY EVEN DROVE IT. I TOOK IT TO AN INDEPENDENT BRAKE/TIRE CENTER AND THEY REPLAC
