DEALER REPLACED BOTH FRONT ROTORS AND BOTH FRONT BRAKE PADS. CAR INITIALLY IMPROVED BUT WITH PROGRESSIVE RETURN OF PROBLEM. TAKEN TO BILL ESTES DEALERSHIP, 4105 WEST 96TH STREET, INDIANAPOLIS, INDIANA, 46268 (PHONE 317-872-3315) THE NEXT FIVE TIMES FOR REPAIR OF PROBLEM. ON 6 OCT 2000, WITH 50,299 MILES (STILL UNDER EXTENDED FACTORY WARRANTY), THE ESTES SHOP DOCUMENTED THE BRAKE PROBLEM. THE CAR WOULD, AND STILL DOES, CHANGE LANES TO THE RIGHT--ONE LANE IN 3 SECONDS AT MILD TO MODERATE BRAKING AT 50 MPH.
