THE DISC BRAKES ON THE 1999 JEEP GRAND CHEROKEE LAREDO ARE THE SAME AS THOSE RECALLED ON THE 1999 JEEP CHEROKEE SPORT (RECALL 00V136000), BUT THE MANUFACTURER IS UNWILLING TO ADMIT TO ANY KNOWN BRAKE DISC DEFECT ON THE LAREDO. THE PROBLEM IS PITTING OF THE DISC SURFACE LEADING TO A PULSATING VIBRATION WHEN THE BRAKES ARE APPLIED.*AK
