WHEN ASKED IF TREAD FLIES OFF NEARLY KILLING PEOPLE BECAUSE OF NAILS THEY SAID YES, AND DENIED MY CLAIM. I ALSO HAVE PICTURES AND I CAN SEE NO NAILS IN MY PICTURES NOR DID ANYONE WHO SAW THE TIRE BEFORE IT WAS SHIPPED TO GENERAL. THEY ARE SHIPPING IT BACK TO ME NOW. THANK YOU FOR YOUR TIME. I CONSIDER THIS TO BE A SERIOUS SAFETY PROBLEM AS I ALMOST ENDED UP UNDERNEATH A SEMI WHEN THE TIRE EXPLODED. *AK
