REAR SUSPENSION FEELS AS IF THE SHOCK ABSORBERS HAVE ALREADY FAILED, CAUSING HARDER THAN NORMAL SHOCKS SPECIALLY WHEN HITTING SMALL BUMPS OR DEEPS ON THE ROAD. KEY GETS STOCK ON THE IGNITION WHEN PARKING AND ATTEMPTING TO REMOVE THE KEY. VEHICLE HAS BEEN IN TWO DIFFERENT DEALERS IN AN ATTEMPT TO CORRECT THE FAILURE BUT IT CONTINUES TO HAPPEN.
