THIS IS THE FIFTH TIME THE VEHICLE HAS BEEN IN FOR AN AIRBAG FAULT PROBLEM WITH THE TENSION SET TO HIGH IN THE AIRBAG. VWOA HAS NOT BEEN ABLE TO APPROPRIATELY FIX THE PROBLEM AND IS PUTTING ME AT RISK DUE TO AIRBAG NOT WORKING CORRECTLY. THE AIRBAG UNIT NOW NEEDS TO BE REPLACED, BUT VWOA DOES NOT KNOW WHAT IS THE ROOT CAUSE OF THE PROBLEM WHICH IS A MAJOR SAFETY CONCERN FOR THOSE WITH THE PROBLEM. ROYAL MOTORS IS THE DEALER THAT THE VEHICLE IS CURRENTLY BEING WORKED ON. THE VEHICLE HAS ALSO BEEN TO DUBLIN MOTORS IN DUBLIN, CA AND LOEBER MOTORS IN CHICAGO, IL.*AK
