ROTORS HAVE BEEN REPLACE TWICE AND MACHINED TWICE IN 40,000 KM. BRAKE PADS HAVE BEEN REPLACE 2 OR 3 TIMES. WAS TOLD BY THE DEALER AND GM CANADA THAT IF YOU DRIVE THE VEHICLE IN THE RAIN THE ROTORS WILL WARP. ROTORS SERVICED @ 10,000KM 20,000 KM 26,000 KM AND 40,000 KM. TRIED TO CHARGE ME WHILE THE VEHICLE WAS STILL UNDER WARRANTY FOR MACHINING THE ROTORS. HAD TO COMPLAIN LOUDLY TO GET THEM COVERED WOULD NOT COVER PADS. STILL TRYING TO GET SOME SATISFACTION FROM GM CANADA. DEALER WOULD NOT ADMIT THERE WAS A PROBLEM WITH THE VEHICLES UNTIL THE CONSULTANT CALLED BACK AND WANTED TO ENSURE HE WOULD NOT GET A BAD RATING ON GM WARRANTY SERVICE QUESTIONNAIRE. THEN ALL OF A SUDDEN THEY HAVE HAD SOME PROBLEMS WITH THE BRAKES/ROTORS ON THESE VEHICLES. *AK
