I E-MAILED GOODYEAR AND TOLD THEM OF MY PROBLEM.THEY RESPONDED BY REPLACING TIRES AND CHARGING ME FOR THE LABOR. MAY 15, 2001, I WAS DRIVING DOWN THE HIGHWAY AT ABOUT 55-60 MPH. WHEN MY FRONT RIGHT TIRE BLEW OUT AT THE INSIDE SIDEWALL FORCING THE TRUCK TO PULL HARD TO THE RIGHT AND OFF THE ROAD. MY RIGHT SHOULDER WAS INJURED DUE TO THIS INCIDENT. I E-MAILED GOODYEAR AND TOLD THEM OF MY PROBLEM.THEY RESPONDED BY REPLACING TIRES AND CHARGING ME FOR THE LABOR. MAY 15, 2001, I WAS DRIVING DOWN THE HIGHWAY AT ABOUT 55-60 MPH.
