THE SPECIFIC FAILURE OF THE PART IN AUTOMATIC TRANSMISSION IS CALLED TORQUE CONVERTER. THIS PART IN THE TRANSMISSION IS RESPONSIBLE FOR SHIFTING THE GEARS. THROUGH MY PERSONAL INVESTIGATIONS, I HAVE FOUND OUT THAT FORD VEHICLES BEFORE THE YEAR 1999 HAVE HAD PROBLEMS WITH THE TORQUE CONVERTERS, REGARDLESS OF THE MAKE OF THE VEHICLE. WITH SO MUCH COMPELLING EVIDENCE ABOUT THE FAILURE OF TORQUE CONVERTERS IN FORD VEHICLES, IT SHOCKS ME THAT THERE HASN'T BEEN A RECALL MANDATED BY THE GOVERNMENT. FORD REFUSES TO PAY FOR THIS DEFECT! PLEASE HELP ME IN RENDERING JUSTICE. *AK
