ENGINE WILL STALL, ESPECIALLY WHEN PULLING OUT IN TRAFFIC. IT USUALLY HAPPEN WHEN ACCELERATING AFTER COMING TO A STOP (BETWEEN 0-15 MPH) AND MAKES THE CAR EXTREMELY UNSAFE TO DRIVE. THE CAR WILL RESTART AND NO LIGHTS COME ON, THEREFORE THE DEALER CANNOT FIND WHERE ANY "CODES" HAVE BEEN SET IN THE ENGINE. I HAVE HAD THE CAR TO THE DEALER NUMEROUS TIMES, AND THEY CANNOT RECREATE OR DIAGNOSE THE PROBLEM. I HAVE ALSO OPENED A FILE WITH PONTIAC. THIS PROBLEM IS A DANGER TO EVERYONE ON THE ROAD, ESPECIALLY GRAND PRIX DRIVERS. WHEN WILL THIS PROBLEM BE INVESTIGATED AND WHAT WILL IT TAKE FOR A "FIX" TO BE IMPLEMENTED? AS IT STANDS NOW, THE CAR IS UNSAFE TO DRIVE, AND THE DEALERSHIP CANNOT OFFER AN EXPLANATION. *AK
