I BROUGHT MY CHERVOLET MALIBU ON 16 OCTOBER 1999 IT HAD 24,000 MILES ON IT. AROUND MARCH OF 2000 I NOTICED THAT THE BRAKE WAS GOING SOFT , MAKING SQUELLING NOISES, SHIMMEY,AND SHAKE WHEN COMING TO A STOP. I TOOK IN TO THE DEALERSHIP THEY SAID THEY WOULD REPLACE THE ROTORS AND BRAKE PADS FOR FREE DUE TO A PROGRAM THEY HAD. THE BRAKES WERE OK WHEN I PICKED THE CAR UP BUT THEY NEVER REALLY SEEMED ALL VERY SHARP TO ME. WHENEVER I BRAKED I HAD TO START EARLY TO MAKE SURE MY MALIBU CAME TO A COMPLETE STOP. THAT WAS MARCH THEN LESS THEN TWO MONTHS LATER IN MAY 2000 WHEN MY CAR HAD 38,000 MILES THE ROTORS GAVE OUT AGAIN. I TOOK IT TO LYNN LAYTON CHERVOLET THEY SAID MY ROTORS HAD WARPED AGAIN.
