AFTER DRIVING ON INTERSTATE FOR AWHILE, THE TRANSMISSION SHIFTED VERY HARSHLY WHEN PULLING AWAY FROM A TOLL BOOTH SENDING MY WIFE'S AND CHILDREN'S HEADS BACK SHARPLY AGAINST THEIR SEATS. THE DEALER SAYS IT WILL NEED TO BE REBUILT. INDEPENDENT TRANSMISSION SHOPS STATE THAT THIS IS A COMMON PROBLEM WITH GMC TRANSMISSIONS AND THAT IT WILL EVENTUALLY CEASE TO FUNCTION, POSSIBLY STRANDING THE PEOPLE IN THE VAN. AFTER ACKNOWLEDGING THIS IN SEVERAL SERVICE BULLETINS, THE GM GARAGE STILL SAYS THAT GM IS NOT RESPONSIBLE FOR THE REPAIR COST OF APPROX \$2000. *AK
