MY BRAKES HAVE STOPPED WORKING WHEN I AM BRAKING AND HIT A BUMP. THE BRAKES ARE ALSO VERY SOFT AND HAVE TO BE PUMPED TO INSURE THAT I HAVE ADEQUATE BRAKING POWER. MY TRANSMISSION SLIPS AFTER COMING TO A STOP THEN STARTING FORWARD AGAIN. ALSO, THE ENTIRE VEHICLE HAS A VIBRATION PROBLEM AND IS DANGEROUSLY DIFFICULT TO CONTROL IN SIMPLE AVOIDABLE MANUEVERS AT 55 MPH AND HIGHER.
