CAR FAILED FIRST VT SAFTEY INSPECTION NOV. 00 BECAUSE SEVERE DEFECT WITH WHEEL BEARINGS - BRAKES PADS AND ROTORS REPLACED WITH ADJUSTMENTS NECESSARY TO WHEEL BEARING AS VERY LOOSE.
